

101. Principle: Whoever causes the death of any person by doing any rash or negligent act not amounting to culpable homicide, shall be punished with imprisonment of either description for a term which may extend to two years or with fine or with both.

Facts: The resident of the adjoining slums were persistently using the park for defecation. On the order of the Chairman of the DDA the park was fenced and electric current was run on the wires on the top. A trespassing slum dweller touched a live wire and was electrocuted. Can the Chairman be held liable for an offence of causing death by negligence?

- (a) No, because getting a public park electrically wired is no rash act.
- (b) Administrative actions are immune to any liability.
