In a vibrant metropolis characterized by towering buildings and crowded streets resonating with the cacophony of car horns and hurried footfall, legalconflicts frequently make their way into the hallowed halls of the court. Amidst the numerous legal matters that come before the case of Mr. Sharma vs the City courts, there is one case that is particularly notable Municipality.

Mr. Sharma, a small businessman, encountered a disagreement with the City Municipality on zoning rules. The City Municipality passed a by-law limiting commercial activities in specific residential districts, including the neighborhood where Mr. Sharma's business was situated. 
